today released 178 Indian fishermen hailing from West Bengal who had been arrested and jailed about two months ago for allegedly trespassing in that country's waters.

Minister of state, Sunderban unnayan affairs, Monturam Pakhira said the fishermen, lodged in Bagerhat jail in Bangladesh, were released at 8 am. Altogether 179 fishermen in 14 trawlers had been arrested by Bangladesh coastguard authorities two months back for trespassing while fishing. One fisherman, Sanjay Samanta (45) died soon after his arrest, Pakhira said. The Bangladeshi authorities had also released the coffin with his mortal remains, the minister said.

The 14 trawlers with 178 fishermen and the coffin had set sail for Namkhana in South 24-Parganas district today, Pakhira said. The trawlers were expected to arrive in Namkhana tomorrow from where the fishermen would go to their respective residences in Namkhana, Kakdwip and East Midnapore, the minister said.

the implementation of Rs 1.65 lakh crore package for Bihar, the Centre has said that it is being implemented as it is for the people of the state and not for any particular government.

The projects under the Bihar package are at different stages of implementation and they are being monitored on regular basis, it said. At a meeting yesterday, Union ministers including Suresh Prabhu (railways), Dharmendra Pradhan (oil & gas) and Piyush Goyal (power) assured BJP state representatives including Sushil Kumar Modi, Prem Kumar and Mangal Pandey on the issue. The representatives met over half a dozen Union ministers and asked them to monitor all these projects on monthly basis for speedy implementations.

"The Prime Minister had announced a package of Rs 1.65 lakh crore for Bihar. We are meeting with different Union ministers to assess the progress over the announced package. All of them have assured that this package is for Bihar and not for a particular government," Leader of Opposition, Bihar Legislative Council, Sushil Kumar Modi told news agency PTI. BJP, which rules at the Centre, was unable to form the government in Bihar following the state elections, raising concerns in certain quarter over the package. "There was a confusion that if the government will not change in Bihar then what would happen (to the package). All ministers told us that the Prime Minister has given package for the people of Bihar.

We are implementing this package," Modi further said: "Two mega bridges are being constructed on the Ganga river. One is at Digha-Sonepur rail-cum-road bridge in Patna and second such bridge is in Munger. Prabhu has told us that these bridges would be ready in a month's time and would be opened by February end." Former Prime Minister Atal Bihari Vajpayee had laid foundation stone of these two bridges in 2003. But these could not be completed during the decade long UPA regime.

department, demanding compensation to instill confidence among engineers skilled and non-skilled workers engaged in other construction projects in the state, the company's official said on Tuesday. The company officials have informed the state government that engineers and contractors were reluctant to carry on work on some other projects despite security being provided by the Bihar authorities.

Earlier, the company also requested for adequate security for its employees engaged in road construction in view of fear among them following the killing of the two engineers.

According to police, the two engineers -- Brajes Kumar and Mukesh Kumar - were killed on December 26 by two motorcycle-borne assailants allegedly for not paying extortion money. An official of the BSC-C&J Joint Venture Ltd said a man named Mukesh Pathak, who works as a shooter for gangster Santosh Jha, has been demanding a "levy" from the company since August.
