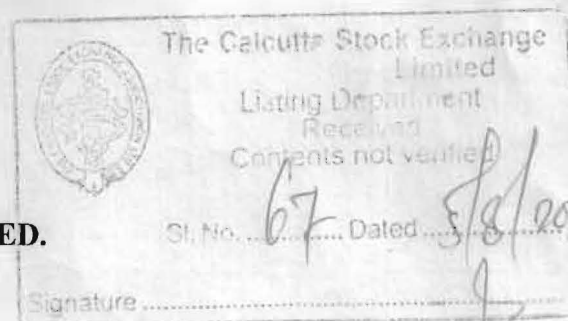

কল্লের জেরে দাবি মমতার

মতো বাসিন্দাদের কাছে পৌঁছেছে কিনা সে বিষয়ে খোঁজ নেন। ঘরছাড়া মানুষদের সঙ্গে কথা বলেন। তাছাড়া এদিন জলপাইগুড়ির ডাবগ্রাম-ফুলবাড়ি অঞ্চলে বন্যা পরিস্থিতি খতিয়ে দেখতে যান সেচমন্ত্রী রাজীব বন্দ্যোপাধ্যায় ও পর্যটন মন্ত্রী গৌতম দেব। মঙ্গলবার থেকে টানা বৃষ্টির জেরে জলপাইগুড়ি জেলায় কৃষিক্ষেত্রে ব্যাপক ক্ষয়ক্ষতি হয়েছে। কৃষি দফতরের প্রাথমিক রিপোর্ট অনুযায়ী জেলাজুড়ে ৭ থেকে ৮ কোটি টাকার ফসল ক্ষতিগ্রস্ত হয়েছে। গত এক সপ্তাহে সমতল ও পাহাড়ে বর্ষার জেরে জলপাইগুড়ি জেলার অধিকাংশ ব্লক জলে ভাসছে। সেই সঙ্গে নদীর ভাঙনে কয়েক হাজার হেক্টর জমি নদীগর্ভে তলিয়ে গেছে। শুধু জলপাইগুড়ি, আলিপুরদুয়ার, কোচবিহারই নয় বরষের জেরে মালদহের চাঁচোলের ফুলহার

নদীতেও ব্যাপক হারে জলস্তর বেড়ে গেছে। বিগত তিনদিন ধরেই ফুলহার নদীর জল বিপদ সীমার উপর দিয়েই বইছিল। বুধবার দুপুর থেকে চরম বিপদসীমার উপর বেড়ে যায় এই নদীর জলস্তর। এরফলে রতুয়া ও হরিশচন্দ্রপুর ২ এবং রতুয়া ১ নম্বর ব্লকে বন্যা পরিস্থিতির চেহারা নিয়েছে। বাড়িঘর ছেড়ে বাসিন্দারা বাঁধের উপর আশ্রয় নিয়েছেন।

তবে জেলা প্রশাসন থেকে ফুলহার নদীর জলস্তর বাড়তে শুরু করার পর্বই হলুদ সতর্কতা জারি করা হয়। এদিন বন্যা কবলিত এলাকা ঘুরে দেখেন তৃণমূল নেতা তাজমুল হোসেন। চাঁচোলের মহকুমা শাসক পুষ্পক রায় জানান, দুটি ব্লকে প্রায় ৯ হাজারের উপর মানুষ ক্ষতিগ্রস্ত। তাদের আশ্রয় দেওয়া হয়েছে। এলাকায় মেডিকেল টিমও পাঠানো হয়েছে।
