It provides a partial wage compensation to women for wage-loss during child birth and child care and to provide conditions for safe delivery and good nutrition and feeding practices. Since its inception in Serchhip 1.1.2017 as many as 1812 pregnant women were covered under the scheme and Rs. 77,66,000 have been disbursed for the same till today. (DIPR)
