

"I warn all goons harassing women in buses that if you try to harass women there are marshals to take care of you," Kejriwal Asserting government's commitment to boost women security in Delhi, he on Monday said the number of marshals on buses in the national capital will be increased by nearly 10,000 on the auspicious occasion of Bhai Dooj. India will grow only when the women of the country grow. Giving free rides to women in buses can prove to be a very big step towards women empowerment, the chief minister said. (PTI)

in the apex court, will succeed incumbent Ranjan Gogoi who will demit office on November 17. The 63-year-old judge will have a tenure of over 17 months as the CJI and is due to retire on April 23, 2021.

The Constitution bench which also includes Justice Gogoi is expected to deliver the keenly awaited Ayodhya verdict by November 15. Justice Bobde, son of eminent senior advocate Arvind Shriniwas Bobde, has been chosen following the. rule of seniority and his name was recommended by Justice Gogoi in a letter to the Centre.

Justice Bogde's warrant of appointment was signed by President Ram Nath Kovind following which the Union law ministry issued a notification on Tuesday naming the judge as the next head of the Indian judiciary.

A 9-judge bench of the apex court headed by the then CJI J S Khehar and which included Justice Bobde had held unanimously that the right to privacy was a constitutionally protected right in India.

Justice Bobde also headed a three-member in-house committee which gave a clean chit recently to CJI Gogoi on a sexual harassment complaint against him by a former apex court staffer. (PTI)
